

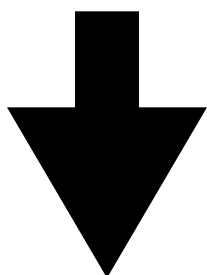

By-Laws St. James Cemetery-Crown Hill

1. Definition

- (A) A Lot is a single grave
- (B) A plot is a multiple of lots

2. Price List of Lots and Plots

Internment right of Lots and Plots shall be sold at prices set by the Cemetery Board and filed with the Ministry.

3. Contract

All purchasers of internment rights must sign a contract with the Cemetery Board as adopted by the Board and filed with the Ministry detailing obligations of both parties and acceptance of the By-Laws.

4. No Resale

No Internment rights may be sold other than to the Cemetery Board. The repurchase is the price paid minus the portion paid into the Care & Maintenance Fund.

5. Transfer Of Rights

If the internment rights are transferred, the rights holder may return the internment Rights Certificate to the Board, who will then issue a new certificate to the transferee. A documentation fee of \$200.00 will apply. If the purchaser transfers the internment right by way of a gift, bequest without consideration, the Board must be provided with written direction or in the event of death, copies of Letters Probate or Administration together with signed directions from the executor or administrator.

6. Cancellation

The Rights Holder(s) may at any time cancel the contract and have the Cemetery re-purchase the Internment Rights if no Rights have yet been exercised, subject to the following conditions. The repurchase price shall be calculated as the original price paid minus the portion deposited

into the Care and Maintenance Fund. If no Care and Maintenance has been paid prior to September 1992 a flat administration fee of \$150.00 will apply.

Internments

7. Permits

A burial permit issued by the Division Registrar showing that the death has been registered or in the case of cremation, a Certificate of Cremation must be deposited with the Superintendent or the Cemetery Board before internment may take place. A non-collapsible Vault or Container is required

8. Written Permission

Written permission must be submitted to the Board for any internment other than the internments Rights Holder for each lot.

9. Cremation Internment

Cremations may be interred in lots other than cremation lots including family plots. Three cremations may be allowed for each lot.

10. Animals

Bodies of animals shall not be placed in either plots or lots in the cemetery.

11. Disinterment

All Disinterment's will be done in accordance with the Cemeteries Act. Disinterments are performed by outside contractors an administration fee applies over and above the cost of disinterment of \$400.00

Monuments & Markers

12. Definition

(A) For the purpose of these By-Laws, a marker shall be understood to be any permanent memorial structure at ground level.

(B) For the purpose of these By-Laws, a monument shall be any marker that is not flush with the ground.

13. One Monument to a Plot

No more than one monument may be erected or placed on a Plot regardless of the number of graves in that Plot.

14. Single Width Graves

Only flat markers flush with the ground and no wider than 36 inches (apron included) are allowed on single graves.

15. Double & Triple Width Plots

Double Plots- Only monuments no wider than 36 inches (base included) Triple or more plots-Only monuments no wider than 60 inches (base included) are allowed.

16. Cremation Markers

All markers shall be 24 inches by 12 inches by 4 inches.

17. Foundations

All monuments shall have a 5 feet deep foundation at the owner's expense. This excludes all flat markers and pillow markers that are sitting on a concrete/ granite pad.

18. Thickness & Heights

(A) All monuments must conform to the following height restrictions.

Monuments up to 32 Inches high must be at least 6 inches thick.

Monuments from 32 to 40 inches high must be at least 7 inches thick.

Monuments from 40 to 48 inches must be at least 8 inches thick.

(B) No monuments higher than 48 inches.

19. Thickness of Flat Markers

Flat markers must be at least 3 inches thick, no concrete foundation required.

20. Foot and Cremation Markers

One marker with a flat level surface may be placed at each grave (in addition to a monument) located at the end of the grave farthest from the monument. All markers placed on graves must be approved by the Cemetery Board.

21. Type of Material

All Markers or monuments must be constructed solely of natural stone or bronze.

22. Corner Markers

Corner markers are required. They must be installed at the corners of the lots and plots, flush with the ground. All corner markers are to be installed with Cemetery Board approval. Additional maintenance to markers subject to Cemetery Board approval.

23. Installments

All monuments and markers are to be installed with Cemetery Board approval.

24. Inscription

No inscription shall be placed on any marker which is not in keeping with the dignity and decorum of the Cemetery.

25. Care and Maintenance Fund

All monuments and markers installed in the Cemetery shall have the proper amount of money deposited in the Care & Maintenance Fund as regulated in the Cemeteries Act.

26. Removal

The Cemetery reserves the right to remove any monuments or markers found to be in contravention of these regulations.

Flowers & Shrubs

27. Fresh Flower & Small Pots

Fresh flowers and small pots may be placed on a grave to commemorate special occasions, however, the Board assumes no responsibility and will remove these and the containers when they become unsightly or they may hold rain water that will freeze over the winter or may break during lawn maintenance (health & Safety issues)

28. Flower Beds

Flower beds must be no wider than the monument or marker and over 16 inches in depth.

29. Shrubs

Small shrubs will be allowed and must be maintained by the owner. The cemetery board reserves the right to prune or remove any that grow to large.

30. Trees

No trees may be planted unless authorized by the cemetery board.

31. Articles prohibited

No chairs, benches, wooden or wire trellis, anchor iron, glass containers or similar articles shall be installed or left upon the lots or plots unless agreed to by the Cemetery Board.

32. Portable Articles

The Cemetery Board will not be responsible for loss or damage to any portable articles left in the Cemetery.

33. Back Assessment

A onetime \$400.00 per grave lot or plots, where no previous Care & Maintenance has been paid and sold prior to 1960

The said By-Laws were passed at a meeting of the Cemetery Board.
